Parliamentary Co-operation activities

WORK PLAN 2016

1. Introduction

The reform of the Parliamentary Assembly of the Council of Europe (PACE), initiated with the adoption of Resolution 1822 (2011)¹, has had significant implications on its working methods and Committee structure.

The overall objective of the reform has been to strengthen the political relevance and effectiveness of the Assembly, making it more visible, by reinforcing its interaction with national parliaments. Enhanced interaction should help PACE to better tailor its activities and priorities so that European-level debates find their way more easily to national parliaments.

To further these aims, in 2012 a Parliamentary Project Support Division (PPSD) was created within the Assembly secretariat, whose prime objective is, in partnership with the secretariats of general Committees and other sectors of PACE secretariat, to devise and promote specific co-operation projects involving parliamentarians and staff of national parliaments.

Through the activities proposed in the 2016 Work Plan (see Appendix 1) and building on the initiatives carried out during 2015 (see Appendix 2), it is intended to ensure that the PACE's key recommendations are better known by national parliaments of Member States and beyond, in partner for democracy parliaments².

Peer-to-peer seminars, capacity building workshops and exchange of good practices, involving a limited number of countries have been preferred to large-scale conferences.

Importance has also been given to identifying issues and projects on which it will be possible to build in the longer term. Although the Plan is formulated for one year, a number of initiatives are conceived with a multi-annual horizon, on the basis of which concrete results at the national level, can reasonably be expected.

By targeting its co-operation with national parliaments on thematic priorities which are at the core of its work, the PACE can usefully complement and reinforce initiatives taken by the Council of Europe at the inter-governmental level.

2. Sources of finance and activities

A number of proposed activities will be financed from the PACE ordinary budget. These include some multilateral parliamentary seminars on supervision of the execution of the judgments of the ECHR, on media freedom, the European Social Charter and on combating corruption, as well as meetings of the parliamentary Network of Women Free from Violence, of the Network to stop sexual violence against children and of the No Hate Parliamentary Alliance. As it happened in previous years the Secretary General has written to the heads of national delegations of PACE requesting voluntary contributions for the two first Networks. In addition, financial resources for the implementation of activities will be provided from outside the ordinary budget of the Assembly.

2.a) CoE/ EU financed Programmes already in the process of implementation

Eastern Partnership Programmatic Co-operation Framework (EaP)

This co-operation framework aims at providing assistance to the reinforcement of democratic reforms in Armenia, Azerbaijan, Belarus, Georgia, the Republic of Moldova and Ukraine.

The framework agreement encompasses co-operation activities, during the period 2015-2017 around five themes: (i) protecting and promoting human rights; (ii) ensuring justice; (iii) combating threats to the rule of law; (iv) addressing the challenges of the information society; and (v) promoting democratic governance.

The Secretariat of PACE has prepared project proposals in relation to all themes (following the Presidential elections in Belarus in October 2015, this country's Parliament is also invited to participate in the projects).

The proposals have been mostly designed at regional level, aimed at organising peer to peer seminars for Members of Parliaments of the region and information / training workshops for the staff of the Parliaments. A few activities will be implemented at national level, mainly on human rights related issues.

South Programme (South)

The Assembly also takes part in the implementation of the second phase of the joint Programme between the Council of Europe and the European Union “Strengthening democratic reform in the Southern Mediterranean”. The Secretariat of the Assembly presented a preliminary list of initiatives for cooperation with the national Parliaments of Morocco, National Palestinian Council (in the framework of their Partnership for democracy status) and Jordan. The proposal foresees regional and national seminars to be organised for Members of Parliaments, as well as for their staff.

2.b) CoE/EU Projects Expected to be launched in 2016

South Eastern Partnership / EU-CoE South Eastern Europe Horizontal Facility (HF) 2016-2018

Another framework agreement is foreseen concerning the countries of South East Europe (Albania, Bosnia and Herzegovina, Kosovo*, Montenegro, Serbia and “the Former Yugoslav Republic of Macedonia”). A preliminary discussion on the structure of the programme, including a parliamentary dimension, is at present under way. A decision on the final project is only expected by early 2016, hence the PACE proposals have not been included in this programme for the time being.

The framework of the SEE Horizontal Facility Programme is based on the monitoring results in the respective countries conducted by the Council of Europe independent bodies and it focuses on four thematic areas: development of justice system, anti-corruption, anti-discrimination and media.

The Secretariat of the PACE was invited to propose parliamentary projects according to these four pillars both by country of operation and in a regional setting.

2.c) Projects submitted for Voluntary Contributions (VC)

Six Council of Europe wide multilateral projects have been submitted by the Secretary General of the Council of Europe to the Committee of Ministers for voluntary contributions, involving different sectors and institutions of the Council of Europe on: democratic society, social rights, combating corruption, no hate, diaspora and immigrant children. Within this context “Parliamentary Campaign to End Immigration Detention of Children” presented by the Secretariat of the Migration Committee, with the backings of the Swiss delegation to PACE, has received financial support from the Swiss Government for the period of October 2015 - September 2016. It is expected that other initiatives linked to the activities of the PACE Committees receive further voluntary contributions in 2016. These projects have been included in the draft CoE programme and budget for 2016 - 2017 projects requiring voluntary contributions.
